Subject: Construction of Community Building on the Plot earmarked for It in E-1, Vasant Kunj

Sir,

I hope this letter finds you in good health. We are writing to you in continuation of our representation submitted to the Hon'ble Member of Parliament, Sh. Rambir Singh Bidhuri, vide No. E1VKRWA/2024-25/COMMUNICATION/70 dated 12 MARCH 2025, as well as the deliberations held in the conference hall of the VC, DDA, on 12 MARCH 2025, in the presence of the Hon'ble MP, your esteemed self, and other DDA authorities. We also refer to the subsequent meeting of the E-1, Vasant Kunj RWA representatives with you in your chamber on 02 April 2025.

2. As mentioned previously, we would like to bring to your attention the situation regarding the Community Centre facilities in the DDA Housing Societies. These facilities have been successfully constructed in earlier and later housing pockets of Vasant Kunj, West Delhi, and in the newer pockets of Dwarka. We request that the same consideration be given to the residents of E-1, Vasant Kunj.

3. We would also like to highlight that the E-1 Housing Society is currently lacking any community facilities for its residents, including space for small social functions. The area is surrounded on all sides by unauthorized, unplanned, and congested zones such as Israel Colony, and villages like Mahipalpur and Rangpuri. These factors severely limit the opportunities for social and cultural connectivity for the residents, especially the children and the elderly, which is essential in an era where community fragmentation is becoming increasingly common.

4. In light of the above, we kindly request that you initiate the process for the construction of a Community Building on the plot earmarked for it in E-1, Vasant Kunj. An expedited response would be highly appreciated, as the residents of E-1 have been waiting for this essential facility for approximately six years.
