Subject: Urgent Request for Intervention – Aggressive Stray Dog in E-1, Vasant Kunj

Dear Sir,

On behalf of the 5,000 residents of E-1, Vasant Kunj and numerous service providers, we seek your urgent intervention regarding a highly aggressive stray dog in our Society. Among the 25-30 stray dogs in our community, this particular dog has repeatedly attacked residents, creating fear, especially among children, the elderly, and workers. Many residents have already been bitten, making it unsafe for people to step out freely.

2. As responsible representatives of the residents of the E1, Vasant Kunj Society, we have been fully supportive animal welfare and peaceful coexistence with stray animals. While we urge the care givers from time to time to feed the stray dogs at the designated places, we have report the bite cases along with the available medical / treatment documents to the Municipal authorities as and when brought to our notice. However, public safety must be prioritized when a single dog becomes a persistent threat. Recognizing this, we consulted a well-established animal welfare NGO that agreed to provide shelter and treatment to this community dog in question for his aggressive behaviour. However, certain dog lovers/care givers in our locality have obstructed this effort, refusing to acknowledge the dog's aggressive behavior—an essential step for placing it in a safe shelter where it can receive proper care.

3. Instead of cooperating in the larger interest of community welfare, these individuals have resorted to threats of legal action, falsely accusing us of attempting to remove all stray dogs. This is completely untrue; our sole request is to ensure that this specific dog is placed in a secure shelter where it can be properly treated, not to disturb the presence of other non-aggressive strays.

4. We respectfully request the Animal Welfare Board of India to:

- (i) Facilitate the lawful sheltering and treatment of this aggressive stray dog under the Animal Birth Control (Dogs) Rules, 2023.
- (ii) Direct municipal authorities (MCD) or a recognized NGO to take custody of the dog for medical evaluation, treatment, and shelter.
- (iii) Issue directions to the residents who are unduly obstructing the proposal of sheltering and treatment of the said stray dog, in the name of AWBI guidelines/ legal provisions, thereby endangering public safety.
