- 1. Hand over the Common Area Maintenance to MCD and,
- 2. Maintain the Common Area to be handed over to MCD till hand over.

Dear Sir.

Maintenance of the common areas to be handed over to MCD has become one of the major issues of the Residents of the E 1, Vasant Kunj Society.

The said common areas are required to be handed over to MCD for maintenance and, till the time of hand over, their maintenance is the responsibility of DDA.

However, DDA stopped maintenance of the Common areas without handing them over to MCD.

The issue of demarcation of the common areas to be handed over to MCD and their maintenance till hand over was raised by the E 1, Vasant Kunj RWA in the High Court mandated meeting held on 14.03.2024 under the chairmanship of the FM, DDA, wherein it was decided that the grievances specific to a particular RWA should be taken care of by the concerned Field Office.

In the above context, the E 1, Vasant Kunj RWA has already written to your good self-vide letter No E1VKRWA/2023-24/COMMUNICATION/058 dated 31 March 2024 for resolution of the issues specific to the E 1, Vasant Kunj Society.

However, the common areas like roads etc of the Society have neither received any cleaning for very long nor are they lit due to non-functional LEDs/halogen tubes at approx 70 poles.

Overall, the Society is in a pathetic condition and requires immediate remedial measures by DDA to ensure proper cleaning of common area which are finally to be handed over to MCD and replacement of the faulty non-functional LEDs/halogen tubes.

In view of the urgency as elucidated above, it is requested to look into the matter on priority please.
