We, the E1 Vasant Kunj Resident Welfare Association (RWA) of Sector E1, Vasant Kunj, New Delhi - 110070 (Society) are encountering a significant issue regarding the incorrect naming and address of our Society in the official records maintained by the Delhi Development Authority (DDA).

In all official documentation and records held by DDA, our Society is incorrectly referred to as "DDA Flats, Sultangarhi Housing, Mehrauli Mahipalpur Road". This discrepancy has been causing considerable confusion among stakeholders, including residents, service providers, and government bodies. It also affects RWA's and residents' dealings with external entities and complicates legal and civic processes.

Therefore, we kindly request that the DDA take immediate action to update its records to reflect the correct name of our Society as "Sector E-1, Vasant Kunj, New Delhi, 110070." We believe that this correction will facilitate smoother operations and communications for our society and help in maintaining clarity.

We appreciate your attention to this matter and look forward to your prompt action to rectify our society's name in DDA's records.
