Subject: Urgent reconstruction request for boundary wall damage of Sector E-1, Vasant Kunj Society

Dear Sirs,

We are writing to you with reference to our recent telephonic discussion regarding the collapse of the Society boundary wall opposite Tower A1, near Gate No. 1, at about 10-11 p.m. on Friday, 11 May 2024. The cause of the collapse is attachment / fastening of the galvanized iron sheet by the DMRC on to the mentioned boundary wall, that resulted in closure of the gaps that had been left by DDA for free flow of the wind. The fastening and closure lead to extraordinary pressure on the wall in the storm last night and its collapse.

Given the security hazard posed due to the collapsed wall, particularly with nearby settlements, and the heightened risk of stray animals entering our society, we urgently request to expeditiously reconstruct the said boundary wall.

We sincerely urge you to prioritize this matter and take swift action to address the issue. Your prompt attention to this urgent request would be greatly appreciated.
