– E1 Vasant Kunj Access and Metro Station-Related Matters

Reference: RWA email letter dated 17th July 2025 regarding urgent request for reopening Gate No.1 or making existing walkway motorable

Respected Sir,

We write to place on record our sincere thanks for convening the on-site meeting on 2nd August 2025 at the site office of the under-construction Mahipalpur / Sector E Vasant Kunj Metro Station, following our detailed communication dated 17th July 2025 on the subject of access-related difficulties faced by residents due to closure of Gate No.1 and limited road infrastructure.

The joint interaction between DMRC officials, the executing agency, and our RWA members was constructive and has raised hope among the residents for resolution of the long-pending issues.

Further, in continuation of the discussions held on 2nd August, another follow-up meeting and feasibility study was conducted on 5th August 2025 between DMRC officials and RWA representatives. We are pleased to record that DMRC has agreed to construct the temporary one-way motorable road at Gate No.4 for four-wheelers, with target completion by 10th August 2025. This decision, once implemented, is expected to bring much-needed relief from daily congestion.

We have separately attached the minutes of both meetings as Annexure I for your kind reference.

We respectfully request formal confirmation on the minutes and timelines of implementation. We once again thank DMRC for its support and understanding, and we look forward to timely execution of the agreed measures in the interest of over 1,200 families residing in Sector E1, Vasant Kunj.

Annexure I

Minutes of Meeting – 2nd & 5th August 2025

Location: Site Office, Mahipalpur/Sector E Vasant Kunj Metro Station

Participants: Officials from DMRC and Contractor Team, Office Bearers and Representatives of E1 Vasant Kunj RWA

Key Decisions Taken:

1. Emergency Access at Gate No.1

DMRC to create and open an emergency access road at Gate No.1 within 2 months from 2nd August 2025.

2. Conversion of Gate No.4 Walkway

Temporary conversion of Gate No.4 pedestrian walkway into a one-way motorable road for four-wheelers to be done by DMRC. Agreed during follow-up meeting held on 5th August 2025. Target completion by 10th August 2025.

3. Restoration and Beautification of Gate No.1

Full restoration and beautification of Gate No.1 to be undertaken by DMRC by December 2025. RWA to submit a separate written request once again.

4. Access to Bypass Flyover

Upon operationalization of Gate No.1, provision of an exit from Sector E1 society to the main road before the start of the bypass flyover to be provided. This will significantly ease outbound traffic and reduce internal congestion.

5. Metro Station Renaming Request

DMRC to review and respond to the RWA's request for naming the metro station as "Sector E Vasant Kunj Metro Station" or "Mahipalpur/Sector E Vasant Kunj." RWA to provide a separate letter for the same once again.
