Subject: Request for immediate repair of faulty street lights within the DDA Flats, Sector E-1 Society.

Dear Sir,

We are writing to bring to your attention a pressing issue that has been persistently affecting the safety and well-being of residents of the DDA Flats, Sector E-1 Society for the last 6-7 months. This urgent matter concerns numerous faulty streetlights within our society. Due to these unserviceable/non-functional streetlights several dark spots have been created in the society, rendering certain areas of the society unsafe and unwalkable. These dark spots pose significant safety risks, especially for ladies, children and senior citizens. Additionally, the presence of strays in these poorly lit areas further exacerbates the safety concerns for our residents.

Despite repeated notifications to the DDA regarding this issue since January 2024, no rectification has been undertaken.

Although not responsible for this maintenance, the RWA took the responsibility of removing and reinstalling these lights at our own expense and even for bearing some wiring costs.

Consequently, it was agreed that the DDA would repair the lights if the RWA removed them for repair and reinstalled them afterward.

Despite this, only 30 street pole lights in the cluster parks have been repaired, and around 61 streetlights still remain non-functional

The said 61 non-functional lights were got removed by RWA approximately two weeks ago, but the DDA's part of repairing has not been done so far.
