Dear Sir,

We hope this letter finds you well. We are writing on behalf of the residents of Sector E-1 Vasant Kunj Society, a community comprising 1,214 flats. Our society includes several green areas that are crucial for the well-being and recreation of our residents. However, compared to other green spaces in Vasant Kunj, our green areas are in poor condition and require urgent attention. While we are separately engaging with the horticulture team of the DDA to address these concerns, certain steps need to be taken by the Horticulture Civil Division of the DDA to enhance our green spaces and overall living environment.

In this regard, we request the following actions from your office on an immediate basis:

1.) Water Supply for Plants: Certain areas of our society lack piped connections for watering the plants, which is essential for maintaining healthy green spaces. We request your office to install underground piped connections to ensure adequate water supply for all plants in the society. Sufficient water sprinklers are also a must for uniform watering and prevention of water wastage.

2.) Relocation of Instructions Board: In our society's central park, a large instruction board for the children's play area is currently affixed on an improper location, causing inconvenience and reducing the usable play area. We request its relocation to a more suitable and conspicuous place. Additionally, we request the installation of another instruction board with clear guidelines stating that the park should not be used by older children for playing football or cricket, as it poses a risk to younger kids and senior citizens. The instructions should also specify that dogs are not allowed in the park and that cycling and other activities that can cause inconvenience to residents are prohibited.

3.) Protection of Trees: Some large trees in the park are facing the challenge of getting uprooted in wind/storm as their roots are not deep enough and secured by adequate earth secured by a fence around them at the permissible distance from the stem. Any uprooting will not only cause loss of tree but may also be fatal to the safety/wellbeing of those around. We request urgent action to provide adequate protection for these trees to ensure their stability and health.

4.) Boundary around the Park with entry gates to allow entry to pedestrians only and to restrict undesirable entry of vehicles, bicycles, and stray dogs into the park: This is

necessary to check nuisance, protection of the greenery from mutilation and ensure safety of the walkers from strays the presence of which has made it unsafe for children and the aged, who are often fearful of using the space. There have been several incidents of attacks by the strays on the park users. Proper boundary/fencing will help mitigate these safety concerns.

5.) Additional Play Equipment: The number of children's play equipment and swings in our parks is currently only around 8-10, which is insufficient for a society of 1214 flats with nearly 90% occupancy. This leads to overcrowding and children not getting their turn to use the play equipment. We request the installation of additional swings and play equipment in our main as well as cluster parks to reduce the pressure on the existing facilities in the central park and to ensure all children have the opportunity to play.

We believe that addressing these issues will greatly enhance the quality of life for all residents and ensure the safety and enjoyment of our green spaces. We kindly request your urgent attention and prompt action on the above matters.
